Sir/Madam,

In reference to your letter no CBSE/AFF/EX-00112-2021/2020-21, dated 02-07-2020 we would like to clarify that our school was previously affiliated to Basic Shiksha Parishad, Uttar Pradesh with the name Ram Shishu Mandir Junior High school, Gorakhpur with classes from Ist to VIIIth. When the school applied to affiliate with CBSE, we surrendered the affiliation of Basic Shiksha Parishad Uttar Pradesh as per guidelines of CBSE at that time and the NOC was granted from CBSE on 01-04-1995 to Ram Shishu Mandir Junior High school, Gorakhpur for upgradation and affiliation.

After that, the permission letter no- CBSE/Aff/DO/21686/1741-45 dated 07-02-1997 issued from CBSE regarding extension of affiliation beyond 1997-2000 has mentioned the name of school Ram Shishu Mandir Higher Secondary School, Gorakhpur.

Later on we applied for upgradation upto XII and the letter no CBSE/Aff/21686/ 2002/ 18186-92 was issued from CBSE on 12-07-2002 which also clearly mentions the name Ram Shishu Mandir Higher Secondary school, Gorakhpur.

That's why we are using the name Ram Shishu Mandir Higher Secondary school Gorakhpur instead of Ram Shishu Mandir Junior High School, Gorakhpur.
